MESSAGE FROM THE Chairman

Good day, ladies and gentlemen. We are approaching our upcoming legislative reception and board meeting on February 12th and 13th, with our reception being held on the evening of the 12th and the board meeting on the 13th. If you need rooms, I would suggest that you reserve them sooner rather than later, with the legislature in session and all the groups coming into town. There will be a shortage of rooms.

I read that there are two bills being introduced on the federal side that will affect our industry. Senate bill S. 3273 and House bill H.R. 6359 both are referred to as the Guaranteeing Overtime for Truckers Act. They deal with paying drivers overtime for over 40 hours. I am not in favor of this at all. It will increase the cost of goods substantially. For the people that have been in this industry, this is not a 40-hour-a-week job. I am not opposed to a driver being paid what they are worth, but this will almost double the cost of goods, so where do we stop?

Another article I read discussed a proposal that team drivers will have to be paid for over 8 hours of sleeper berth. I don't know if you can see the irony in this. If the feds mandate that you have to take 10 hours off duty sleeper and off duty, and now they want the company to pay for two hours of federally mandated time. I don't know who dreamed this up, but it was not thought out at all.





States Waive HOS for Fuel Deliveries Amid Severe Weather

Extreme Cold Prompts Efforts to Prevent Shortages

Governors from several states have issued emergency proclamations waiving federal hours-of-service requirements for truckers carrying fuel, to prevent shortages to safeguard people due to extreme cold weather.

Although some states issued orders several days ago that soon expire, others with longer duration emergency orders are Alabama, Arkansas, Indiana, Mississippi, Missouri, Nebraska, New York, North Carolina, South Dakota and Tennessee.

Alabama Gov. Kay Ivey's proclamation bans price gouging for the sale or rental of any commodity or rental facility Jan. 14-27. It also waives HOS requirements for 30 days from Jan. 14 for truckers bringing emergency- or disaster-related supplies, goods and services to assist with the extreme weather emergency.

Ivey also instructed relevant transportation agencies in the state to arrange necessary documents to assist with the movement of equipment and supplies. For example, the state department of transportation is allowed to issue waivers for vehicles or combinations of vehicles and (divisible/nondivisible) loads with weights, dimensions or combinations exceeding maximum legal limits. Transporters must display proper vehicle markings, flags and oversize signs, and have escorts as defined in Alabama's procedures. Alabama's order doesn't waive insurance requirements or weight limits on bridges.

Arkansas Gov. Sarah Huckabee Sanders waived HOS regulations through Jan. 26 for commercial vehicles carrying heavy equipment, oversized loads, electric power equipment and essential goods to people (groceries, medical and pharmaceutical items) and animals (poultry and livestock).

Indiana Gov. Eric Holcomb's emergency order, which expires Jan. 25, halts HOS regulations for truckers transporting propane gas that is used by 500,000 Hoosiers for heating homes, businesses, schools and public buildings.

The order, signed Jan. 15, said current demand exceeds local supplies, forcing distributors there "to experience shortages in supply, long lines at terminals, and related transportation challenges such as a shortage of drivers and the necessity for existing drivers to travel longer distances in search of propane gas."

Extreme freezing temperatures and severe winter weather prompted Mississippi Gov. Tate Reeves on Jan. 16 to waive HOS regulations through Jan. 30 for transporting fuel and other essential goods.

Nebraska's emergency order by Gov. Jim Pillen lasts for 30 days from its issuance Jan. 12 to waive HOS drive time regulations for drivers "hauling residential heating fuel and oils or fuel used to generate power for residential heating into or within Nebraska." Drivers operating under this order must carry a copy of the state declaration to prove their direct support to Nebraska during the emergency.

New York Gov. Kathy Hochul's HOS waiver (Jan. 12-Feb. 11) "is necessary to ensure that crews can clear vital roadways and hasten the movement of utility power restoration crews into New York state."

North Carolina's HOS waiver order expires Feb. 8. Gov. Roy Cooper declared a statewide emergency Jan. 8 and temporarily waived/suspended motor vehicle regulations. He directed that the HOS waiver applies to drivers transporting:

- Essential fuels, food, water, nonalcoholic beverages, medical supplies, feed for livestock and poultry
- Livestock, poultry and crops ready to be harvested
- Vehicles used to restore utilities and transportation services

South Dakota Gov. Kristi Noem's HOS waiver remains in effect until Feb. 11 for the transportation and delivery of residential heating fuels into or within the state. Noem noted when she issued the Jan. 12 order that state residents faced "extremely low inventories and outages of residential heating fuels and the return of normal supply flows to fuel terminals in South Dakota is unknown."

Patrick Sheehan, director of the Tennessee Emergency Management Agency, declared a winter weather emergency and fuel transportation regulatory relief order Jan. 13 under authority granted by the governor.

Through Jan. 27, HOS is waived for commercial motor vehicle operators who are providing fuels (including fuel oil, diesel, gasoline, kerosene, propane, liquid petroleum, and other refined petroleum products and heating fuels).



NEW YEAR'S RESOLUTION:

Prioritize Driver Health and Safety

Statistics show that truck drivers are among the least healthy groups in the workforce, so a new year is a good time for the industry to prioritize their health and safety.

Truck drivers are statistically the most unhealthy group of people in the workforce, according to Steve Kane, president of RollingStrong, a wellness provider for the transportation industry.

According to a CDC study released last decade, long-haul truck drivers' health is worse than the average national working population:

- Prevalence of obesity is twice as high (69% vs. 31%).
- Prevalence of morbid obesity is twice as high (17% vs. 7%).
- Prevalence of current cigarette smoking is more than double (51% vs. 19%).
- Prevalence of self-reported diabetes is elevated (14% vs. 7%).
- More than twice as many drivers are not covered by health insurance or a health care plan (38% vs. 17%).
- A lower percentage of drivers perceived their health status as excellent, very good, or good (84% vs. 94%).

When truck drivers suffer from poor health, their safety, the safety of others, and their freight are at risk.

"They [drivers with poor health] have less reaction time, they have micro-sleeps or fall asleep at the wheel more often, or are more prone to a catastrophic event behind the wheel, such as a heart attack or stroke," Kane said. "That not only puts them at risk for their personal health, but it puts our highways at risk, and it puts the driver at risk, and certainly other families that are on the road at risk."

This has been an ongoing issue in the industry, but 2024 could be the year for change. For change to happen, drivers and fleet managers need to understand how driver health got to this point in the first place.

How did we get here?

The environment truck drivers work in does not promote healthy living, which in turn does not help drivers practice



safe driving. Due to the nature of their job, drivers are sedentary for hours per day. While sitting may seem harmless, it can have many adverse effects on one's body and health, according to Kane.

"We've actually analyzed what happens when you're in that seated position for a long period of time," Kane said. "Those hips get hinged, and we turn off the glutes and the hands, and our shoulders and our chin come forward, and we get a misalignment of the spine. It just creates a whole bunch of issues from your head all the way down to your toe, and those issues prevent us from even feeling capable of doing some of the other things that we should be doing, like walking, jogging, or going to the gym, because our bodies just get very out of alignment."

Accessing healthy food and exercise on the road is also difficult. According to Kane, most truck stops do not provide healthy food options, sometimes even to the extent that McDonald's truck stop restaurants do not offer healthy food options that they do at their other, non-truck stop locations. And this lack of access keeps truck drivers from making healthy choices.

"Some of the truck stops do have a cooler or a small section that has some healthy options, but when you're a person that isn't educated or not aware of what the right choices are, and you're also very limited on time ... that's the perfect storm to make a bad choice. And that's often what happens," Kane explained.

What drivers and fleet managers can do

In this perfect storm of unhealthiness, what can drivers do to prioritize their health? How can fleet managers and staff support their drivers in being healthy? According to Kane, change has to start at the top; fleet managers must make healthiness part of their company culture, and they must bring healthiness into the safety conversation.

With the support of their fleet, drivers should prioritize their health more this year. This will look different for each driver, but the basics would be to eat healthier and move your body more while on the road to avoid sedentary habits.

And while being healthier is a safety issue, there are also specific ways drivers can pledge to be safer on the road this year, such as:

Avoid distracted driving. Distracted driving isn't just a problem for regular drivers; it's also something professional drivers can be guilty of. According to Corey Woinarowicz, chief revenue officer of NoCell Technologies, a software company that helps drivers stay focused on the road, drivers should take precautions

- before hitting the road to stay focused, such as putting their phone in "do not disturb" mode.
- Don't put yourself in a bad situation. When possible, drivers should give themselves extra time when traveling to a destination. "You don't want that stressful drive. You're hurrying," Ina Daly, an XPO driver with 40 years of experience, explained. "That lends to bad driving behaviors like tailgating and speeding, which leads to accidents. Don't put yourself in that situation."

New Year's resolutions, however, can be challenging to keep. According to a Forbes survey, only 6% of people follow through with their resolutions; most quit within the first few months.

To keep a resolution that sticks, keep your goal realistic, specific, and flexible. Kane also suggests sharing your goal with someone who will hold you accountable for achieving it. Don't punish yourself if you get off track. It's important to remember that progress is the main goal.


RULES:

Driver may be nominated for Driver of the Month for any outstanding act of heroism, a contribution to highway safety, an extraordinary act of courtesy, an exceptional deed or act of service to mankind within the community reflecting positively on the motor carrier industry, or for a long period of safe and courteous driving. An outstanding act shall be deemed to mean unusual or other than the normal every day courtesies afforded by truck drivers.

ELIGIBILITY:

- 1. The nominated driver must be an employee of a member in good standing of the South Dakota Trucking Association.
- The nominated driver must have been an employee of the present employer for at least two years and have a minimum of five years overall experience.
- 3. South Dakota domiciled* drivers are eligible for nomination for an outstanding act performed in any state. * The intent of the word "domiciled" shall be interpreted to mean: Any driver reporting to or regularly dispatched from a terminal within the state of SD (in keeping with the Federal Motor Carrier Safety Regulations definition of his/her home terminal) regardless of where the driver may dwell.

- A driver may receive the Driver of the Month award only one time in any contest year. He/she may be renominated in any subsequent year.
- Nominations for outstanding acts on the highway shall be accompanied by supporting evidence (letters, statements, news clippings, etc.). A clear, factual account is absolutely necessary. Vague generalizations will not be accepted.
- A copy of recent driver motor vehicle record check must accompany the nomination.
- 7. Drivers nominated and not selected as Driver of the Month will be held over and used in the following month's selection.
- 8. Entries must be in the SDTA office no later than the 10th of each month for that current month's contest.
- 9. Nominations may be made by any party, but must be approved by the employer or a representative of the employer.
- 10. The annual contest will run from September of the previous year through August of the current year.
- 11. Company agrees to submit a professional head and shoulders photo of the winning driver.

The Federal Motor Carrier Safety Administration is reviewing six research papers on topics that include in-cab monitoring, automatic emergency braking and forward collision warning technologies as it weighs revision of its motor carrier safety fitness determination rules, the agency said.

The so-called Notice of Data Availability published Jan. 12 in the Federal Register "identifies information the agency has become aware of and provides an opportunity for public comment," FMCSA said. "The agency may consider this information in preparation for further regulatory action following an advance notice of proposed rulemaking."

Safety fitness determinations are currently based on an analysis of existing motor carrier data, collected during an investigation, and a compliance review conducted at a carrier's place of business and/or remotely through a review of its records using a secure portal.

Comments on the data notice must be received by Feb. 12. The request for comment comes after FMCSA on Aug. 29 posted an advance that could allow it to scrap or modify the current way it evaluates motor carrier fitness, or even develop a new method that could incorporate the agency's Compliance, Safety, Accountability Safety Measurement System, an unpopular idea among many motor carriers.

The six studies cited by FMCSA for review include:

• Jennifer Bell: "Evaluation of an in-vehicle monitoring

- system to reduce risky driving behaviors in commercial drivers: Comparison of in-cab warning lights and supervisory coaching with videos of driving behavior"
- Maio Cai, et al.: "The association between crashes and safety-critical events: Synthesized evidence from crash reports and naturalistic driving data among commercial truck drivers"
- Guang Xiang Chen: "Impact of federal compliance reviews of trucking companies in reducing highway truck crashes"
- Jessica Cicchino: "Effectiveness of forward collision warning and autonomous emergency braking systems in reducing front-to-rear crash rates"
- Tsippy Lotan and Tomer Toledo: "In-vehicle data recorder for evaluation of driving behavior and safety"
- Department of Transportation, National Highway Traffic Safety Administration, FARS/CRSS coding and validation manual

Public comments on the fitness determination ANPRM ended Nov. 29, with only roughly 20 comments. Most leaned in support of the idea, but want to see what the agency does first with the proposal to change the fitness determination.

American Trucking Associations said it appreciates the agency's attempt to develop a new methodology to determine when a motor carrier is fit to operate commercial motor vehicles in or affecting interstate commerce.

FMCSA Weighs Carrier Fitness Determination continued from Page 23.

"For an SFD to be an accurate representation of a motor carrier's fitness to operate, determinations must be based on a consistent and uniform data source. Unfortunately, data sufficiency concerns remain a serious limitation," ATA wrote. "The Government Accountability Office has previously raised concerns about data sufficiency as part of the CSA/SMS methodology."

In comments, the National Transportation Safety Board said that for more than two decades it has repeatedly issued recommendations to address the safety deficiencies with the FMCSA's compliance review program and has called for SFD rulemaking to address the "critical need."

"The NTSB strongly supports this initiative but remains concerned with the sluggish pace of the FMCSA's efforts to develop a robust SFD process that will effectively use FMC-SA data and resources to identify unsafe motor carriers and remove them from our nation's roadways," NTSB said.

"As FMCSA pursues the development of a new methodology to determine when a motor carrier is unfit to operate, the agency must avoid relying on the Compliance, Safety, Accountability and Safety Measurement System programs," the Owner-Operator Independent Drivers Association wrote. "Since their inception in 2010, CSA/SMS have completely failed in their objective to reduce injuries, fatalities and crashes. "This will not change until CSA/SMS incentivizes actual safety performance instead of regulatory compliance."

"The Commercial Vehicle Safety Alliance does not support FMCSA retaining the current three-tiered rating system of Satisfactory, Unsatisfactory and Conditional," the inspectors trade organization wrote. "The current system can be misleading and should be simplified for clarity."
